ANNUAL APPROPRIATION ORDINANCE 2025-2026

AN ORIDNANCE ENTITLED THE ANNUAL APPROPRIATION ORDINANCE FOR FISCAL YEAR BEGINNING OCTOBER 1, 2025, APPROPRIATING THE SUM OF \$3,344,178.00 TO DEFRAY THE EXPENSES AND LIABILITIES OF THE CITY OF STANLEY FOR SAID FISCAL YEAR, SPECIFYING THE OBJECTS AND PURPOSES FOR WHICH SAID APPROPRIATION IS MADE, AUTHORIZING A LEVY OF SUFFICIENT TAX UPON THE TAXABLE PROPERTY, PROVIDING FOR REPEAL OF CONFLICTING ORDINANCES, DIRECTING THE CITY CLERK TO FILE CERTIFIED COPIES OF THIS ORDINANCE WITH THE COUNTY COMMISSIONERS AND IDAHO SECRETARY OF STATE, AND PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED by the Mayor and Council of the City of Stanley, Custer County, Idaho:

Section 1. That the sum of \$3,344,178.00 be, and the same is hereby appropriated to defray the necessary expenses and liabilities of the City of Stanley, Custer County, Idaho for the fiscal year beginning October 1, 2025.

Section 2. The objects and purposes for which such appropriation is made, and the amount of each object and purpose is as follows:

Section 3. That a general tax levy of \$102,958.00 on all taxable property within the City of Stanley be levied for the general purposes of said City, for the fiscal year beginning October 1, 2025.

Section 4. All ordinances and parts of ordinances in conflict with this ordinance are hereby repealed.

Section 5. The City Clerk of the City of Stanley is hereby directed to file a certified copy of this Ordinance with the County Commissioners of Custer County, Idaho, and the Idaho Secretary of State, in accordance with Idaho Code 50-1003 and 63-804.

Section 6. This ordinance shall take effect and be in full force upon its passage, approval, and publication in one issue of the Challis Messenger, the official newspaper of the City of Stanley.
