

CITY OF STANLEY, IDAHO ORDINANCE No. 222

AN ORDINANCE OF THE CITY OF STANLEY, CUSTER COUNTY, IDAHO AMENDING TITLE 2, "ADMINISTRATION AND PERSONNEL" OF THE STANLEY CITY CODE AS FOLLOWS: AMENDING CHAPTER 2.04 CITY COUNCIL, SECTION 2.04.020, SPECIAL MEETINGS: AMENDING THE PROVISION FOR DESIGNATING THE PLACE WHERE SPECIAL MEETINGS MAY BE HELD; CHAPTER 2.08 CITY CLERK, SECTION 2.08.010 DUTIES: CHANGING THE TITLE, AMENDING THE PROVISION FOR APPOINTING THE CITY CLERK, AND THE STATEMENT OF DUTIES; AMENDING CHAPTER 2.12 CITY TREASURER, SECTION 2.12.010 APPOINTMENT: AMENDING THE PROVISION FOR APPOINTING THE CITY TREASURER; AMENDING CHAPTER 2.16 POLICE DEPARTMENT, ADDING SECTION 2.16.030 CONTRACT: TO PROVIDE FOR CONTRACTING FOR LAW ENFORCEMENT SERVICES WITH CONSENT OF THE CITY COUNCIL; AMENDING CHAPTER 2.16 POLICE DEPARTMENT, ADDING SECTION 2.16.040 OTHER PERSONNEL: TO PROVIDE FOR APPOINTMENT OF A CODE ENFORCEMENT OFFICER; AND REPEALING CHAPTER 2.20 FIRE DEPARTMENT.

WHEREAS, The City Council of the City of Stanley finds it necessary to update its City Code to clarify certain procedures, to remove unnecessary provisions, and to add new provisions in furtherance of the health, safety and welfare of the City of Stanley.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF STANLEY, IDAHO AS FOLLOWS:

**Section 1:** That Title 2, Chapter 2.04, Section 2.04.020 of the Stanley Municipal Code is hereby amended as follows:

**2.04.020: SPECIAL MEETINGS:**

Special meetings may be called by the mayor or by three (3) members of the council and such special meetings shall be held at a place designated by the mayor or three (3) members of the City Council.

**Section 2:** That Title 2, Chapter 2.08, Section 2.08.010 of the Stanley Municipal Code is hereby amended as follows:

**2.08.010: APPOINTMENT AND DUTIES:**

The city clerk shall be appointed by the mayor for a term of two (2) years, with the consent of the City Council (Idaho Code 50-204). In addition to the powers and duties prescribed by state statutes, the city clerk shall have the power and it shall be his the clerk's duty to keep the city seal and affix it to all instruments, bylaws, and ordinances required to be attested by the clerk. ~~He~~ The clerk shall have the custody and safe keeping of all public records, papers, documents, ordinances, orders, and instruments of the city and such other papers in which the city is interested as may be delivered to the clerk's ~~his~~-custody for safe keeping.

**Section 3:** That Title 2, Chapter 2.12, Section 2.12.010 of the Stanley Municipal Code is hereby amended as follows:

**2.12.010: APPOINTMENT:**

The city treasurer shall be appointed by ~~the city council~~ the mayor for a term of two (2) years, with consent of the City Council (Idaho Code 50-204).

**Section 4:** That Title 2, Chapter 2.16 of the Stanley Municipal Code is hereby amended by the addition of a NEW section 2.16.030 to read as follows:

**2.16.030: CONTRACT:**

In lieu of a city police department the City Council shall have the authority to contract for law enforcement services.

**Section 5:** That Title 2, Chapter 2.16 of the Stanley Municipal Code is amended by the addition of a NEW section 2.16.040 to read as follows:

**2.16.040: OTHER PERSONNEL:**

The mayor may appoint a code enforcement officer.

**Section 6:** That Title 2, Chapter 2.20 of the Stanley Municipal Code is hereby repealed.

**Section 7: Repealer:** All ordinances, policies or parts thereof, which are in conflict herewith, are hereby repealed.

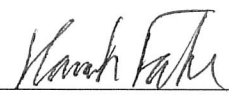
**Section 8: Severability:** Should any part or provision of this ordinance be declared by the courts to be unconstitutional or invalid, such a decision shall not affect the validity of the ordinance as a whole or any part thereof other than the part so declared be unconstitutional or invalid.

**Section 9: Effective Date:** This ordinance shall be in full force and effective from the date of passage and publication according to law.

**Section 10: Codification:** The City Clerk is directed to forward the signed and approved ordinance to the codifier for codification.
